Abstract

Building legal knowledge scale for the laws of some games for fourth year, college physcale education students – Babylon universiy.

The reesarcher used the the descriptive method and the sample consists of (90) students.The researcher used questionnaire forms as a data collection tool.The questionnaire included (194) items for (5) games (volleyball,handball,football, basketball and track and field) in addition to English termindagy.

The scientiic coaditions were verified through validity test and stability through split – half method.The stability reliability was (0.91) The results showed that legal knowledge of the students was weak and there were difereuces of knowledge of the different the games.

The researcher recommended paying more attention to the subject of game laws reference by the deanary and teachers,conducting a similar study on fimale students,and making students explain legal items to their colleagues.
